Reforms for Diversity and Inclusion in Higher Education Institutions in India

The Centre for Policy Research in Higher Education (CPRHE) of the National Institute of Educational Planning and Administration (NIEPA), New Delhi is organising a Policy Dialogue Webinar on "Reforms for Diversity and Inclusion in Higher Education Institutions in India" on 15 December 2020 at 15:00 hrs – 17:30 hrs (IST).

The empirical evidence generated by CPRHE/NIEPA study and other studies show the growing diversity of student body in institutions of higher education in India. A major share of the students in higher education in India belong to socially disadvantaged groups and economically poor households. Many of them are first generation higher education learners graduated from government schools in rural areas following regional language as the medium of instruction. The affirmation action policy, no doubt, has helped in bringing students from deprived groups and diverse backgrounds to institutions of higher education. However, the institutional structures and practices have been less sensitive to the changing dynamics in the classrooms and on the campuses as a result of the increasing student diversity.

The National Education Policy (NEP) 2020, while fixing targets for expanding higher education, emphasises on equity and inclusion as foundational premises for transforming education system in the country. It calls for evolving strategies at the institutional level to manage diversity so that the efforts initiated and success made at the entry level can be extended to facilitate academic integration and evolving inclusive campuses. This policy dialogue addresses the need for institutional reforms to evolve strategies to ensure equity in learning outcomes and in the employment markets.

The Major Objectives of the Policy Dialogue are:

- 1. To discuss the nature and forms of challenges faced by students from diverse socio-economic groups in HE institutions;
- 2. To analyse policy support to develop institutional diversity action plans to advance equity and inclusion in higher education in India;
- 3. To provide a platform to guide the development of an institutional diversity action plan for achieving academic integration and developing socially inclusive higher education campuses in India.

The webinar will bring together policy makers, institutional leaders and administrators and academics.
