Prof. N.V Varghese, Vice-Chancellor and Chairperson of the Academic Council extended a warm welcome to all the members of the Academic Council.

Dr. Sandeep Chatterjee, Registrar & Secretary, Academic Council, NIEPA briefed about the newly constituted and expanded Academic Council, as per the provision contained in the revised Memorandum of Association and Rules, 2020 of the Institute.

The Vice-Chancellor briefed the Council members about NIEPA and its various activities. He started with remembering all the dear colleagues and advisors to NIEPA who lost their lives due to Covid and recalling their immense contributions in NIEPA's varied activities. He next emphasised the contributions and role of NIEPA in policy and planning support to the union and



state governments as well as different institutions over the decades and years of its existence. He appraised the members about the Report of the National Committee on Credit Transfer Framework wherein NIEPA was assigned the role of the Secretariat and the report has been submitted to the Ministry of Education. He also shared about the report on Establishing International Branch Campuses in India: A survey among 'Top 200' Universities, which is also uploaded on NIEPA website. In addition, series of efforts of NIEPA with respect to NEP 2020 and incorporating several dimensions of NEP 2020 in the training programmes was briefed to the members. He further informed that NIEPA has identified and analysed some of the key areas in NEP 2020 and brought out the document titled "NEP 2020 – Implementation Strategies". The same is uploaded on NIEPA's website. He also mentioned that despite the pandemic, there was a smooth transition from face-to-face to online programmes, including timely start of new Academic Session 2021-22 and IT/ICT support extended for the teaching and training programmes.

Thereafter, the agenda-wise items were taken up by the Registrar & Secretary, Academic Council for consideration of the Academic Council.

Agenda Item No. 28.1 Confirmation of minutes of the 27^h meeting of the Academic Council held on March 23, 2021

It was informed that the minutes dated 24.03.2021 of the 27th meeting were circulated to all members of the Council and one of the comments received on Agenda Item 27.3.7(c), was incorporated and the revised minutes dated 08.04.2021 were circulated.

Agenda Item No. 28.2 Considering action taken report on the decisions of the 27th meeting of the Academic Council held on March 23, 2021

The Council noted the information with satisfaction, as given in the Action Taken Report.

Agenda item No.28.3: Reporting Items:

28.3.1 Status of the Training/Workshops/Seminars conducted up to September, 2021

The Council noted the information with satisfaction.



There was a discussion on to write the reasons or process for timely reporting the non-conduct of the trainings/workshops/seminars through the concerned Departments/ Centres to the PMU and Vice-Chancellor, so that it is finally rescheduled and conducted.

28.3.2 Review of the Status of Research Studies up to September, 2021

The Council noted the information with satisfaction.

There was a discussion on prioritizing completion of research projects and to encourage all faculty members to publish the research findings in the form of occasional papers (working paper series), journal articles or books, as research outcomes. The concern of members about delay in completion of research or submission of reports, fixing deadlines, justification for extension, given if any, and incentive for timely finish were also discussed. Specific work or achievement if any during the corona period, including publications shall be separately mentioned by the PMU.

28.3.3 Result of Viva Voce Examination of Ph.D Scholars

Three (03) NIEPA scholars were awarded the degree of Ph.D (Doctor of Philosophy). The Council noted and approved the information with satisfaction.

28.3.4 Submission of Ph.D. thesis for evaluation

Five (05) Ph.D scholars submitted their PhD thesis for evaluation. The Council noted the process followed and information given, with satisfaction.

28.3.5 Report on Admission for Integrated M.Phil-Ph.D. programme for the year 2021-22

The Council noted and approved the information with satisfaction.

28.3.6 Final result of M.Phil. programme for 2019-21 batch

28.3.7 Eligibility of Assistant Professors to supervise PhD scholars

28.3.8 Reporting matter of pursuing two degrees simultaneously from two different Universities, the case of Ms. Reetu, Integrated M.Phil.- Ph.D Scholar

The Council noted that Ms. Reetu student of integrated M.Phil/ Ph.D Programme was not permitted to pursue two degrees simultaneously from two universities. She has voluntarily withdrawn/ cancelled her admission from IGNOU where she was registered for MA (Sociology)

Agenda Item No.28.5 Considering the revised fee structure for M.Phil. and PhD programme and inclusion of few additional heads

The Council noted the information with satisfaction and approved the revised fee structure, w.e.f Academic Year / Session 2022-23. It was recommended to report the item in the next meeting of the Board of Management.

There was a suggestion from the council to explore the possibilities of initiating insurance/mediclaim policy for the students, within the medical fee proposed now.

Agenda Item No. 28.6 To consider the formula for conversion of CGPA into percentage

The Council noted the information with satisfaction and approved the same. It was recommended to report the item in the next meeting of the Board of Management.

Some members of the Council were suggestive that NIEPA shall undertake a study for fixing the norms of evaluation and assessment across disciplines, for the UGC / HEIs and suggest uniformity or a policy, if possible. The national and international norms be studies, including the desired changes needed under NEP-2020. The matter is certainly of academic interest and can itself be a good research topic.

Agenda Item No. 28.7 Proposal for online PGDSLM course

The idea was received well and appreciated by all the members of the council. It was informed by the Chairman that the details of the proposal will be further worked out, in quality and contents, entering into a consultative process and stakeholder's deliberations. A right combination of dual-mode teaching, theory and practice will be attempted, ensuring its quality and effectiveness, so that it becomes an acceptable model. There was a suggestion to incorporate the international discourses in this area as a background note and its implications in the Indian context, which was equally appreciated. It was decided that deliberations and recommendations of the Expert Group Committee and the Board of Studies will be shared for comments.



Agenda Item No. 28.8 Any other item:

As a matter of discussion and suggestions received, it was suggested that:

- 1. A research study shall be undertaken on the effects of online versus offline classes, as a method of teaching and course dissemination across disciplines, in Higher Education Institutions (HEIs), in the context of Covid_19 initiatives and circumstances.
- 2. We need to work out how to reduce the cycle time after submission of thesis and methodology when some corrections/modifications are suggested by the examiner(s) and delay in viva-voce thereof. It was, therefore, pointed out that the supervisor certifies that corrections are being carried out before the viva-voce examination is organised.
- 3. To check the title cover of the thesis / dissertation, as per other CUs/HEIs, and bring congruence or uniformity.

The meeting concluded with a vote of thanks to the member and the Chair.
